The Town of Exeter is accepting sealed bids for Haying of the Town Farm property (a 20-acre parcel located on South County Trail, Exeter, Rhode Island, described as Plat 62/Block 2/Lot 1) for a three-year period to run December 7, 2020, through November 30, 2023.

No haying of subject property is to commence prior to current year payment of good funds with the Town Treasurer.
